### **Approval of the Minutes**

### **Presentation and Discussion**

Kath Rogers, Volunteer Coordinator for California Against Slavery CASE (Californians Against Sexual Exploitation)

A circulating petition calls for heavier consequences for those convicted of human/sex slave trafficking. Currently the max is 8 year sentences and CASE changes to 15 years. Many exploited women are seen on El Cajon Blvd as prostitutes and are actually slaves and police are not being perceived as a safe resources. Los Angeles is the largest human slave area in the nation and there are estimated 32 million worldwide averaging 12 to 14 years of age. Many victims are domestics girls who are runaways or have no community ties. There is a rise of girls being sold/bought on the internet as it is not as risky as trading drugs and very hard to trace transactions. There are not enough resources to keep up with this issue. There is a lack of law enforcement training and the CASE, if passed, provides for training funds through fines paid. Fiscal analysis states low financial impact.

Point of Order by Executive Director Scarborough that the Commission, per the advice of the City Attorney's Office, cannot take a position on a ballot initiative.

### **Public Comment**

A representative from the SAFE Campaign thanked the Commission for increasing their awareness of this devastating issue.

#### **Old Business**

1. Joni Halpern from Supportive Parent Information Network inquired about a letter the Commission was sending regarding the CalFresh program. Commissioner Alcock stated she would follow up on distribution of the letter.
