601: Alex Ward, Greater Golden Hill Community Development Corporation

Introduction to revitalized CDC with opportunities for planning committee support.

602: Grape Street Square

On June 6, 2022 a driver crashed into Grape Street Square destroying many of the community amenities as well as Native Poppy, which remains temporarily closed. The square and adjacent intersection are known conflict points with multiple accidents in the past many years. The community deserves a safe space to gather and to feel safe supporting our local businesses. The GGHPC is committed to creating a space for our neighbors to share their vision for a safe and community focused Grape Street Square.

701: Park Blvd Mobility Improvements - Balboa Park

In late 2022, the City of San Diego will be restriping Park Blvd within Balboa Park in conjunction with a pipeline replacement project. GGHPC to consider supporting the restriping plans the City presented the Balboa Park Committee in June 2022.

702: Golf Course Drive Design

The City has provided 60% design plans for Golf Course Drive with multiple options for the lighting design. GGHPC to consider each option and forward to design team the community preference. Additional comments to the design team may be considered as well.
