#### **DISCUSSION:**

Commissioner Otsuji noted landscape discrepancies between the applicant's hearing presentation handout documents and the project's Exhibit "A" plans regarding landscape treatments on the parking structure and planters surrounding the building structures. Mr. Wahl, applicant's representative committed to providing trellis and landscape features as shown on the applicant's handout. Commissioner Otsuji requested City staff to include permit conditions and/or plan exhibits to ensure compliance.

Commissioner Otsuji recommended existing manufactured slopes on the north to be re-landscaped and the project meet all landscape requirements for all parking areas in the development. Mr. Wahl, applicant's representative committed to evaluating the slope landscape.

Commissioner Otsuji recommended the applicant evaluate the project onsite traffic circulation, especially through the main entry way on Via de la Valle and taking a left towards the new parking structure. Potential for problems with traffic backing up. Mr. Wahl, applicant's representative committed to evaluating the entry way.

SUSTAINABLE BUILDING FEATURES: [COMMISSIONER NASLUND] "THERE ARE LOTS OF PLACES ON THIS PROJECT, NOT OVER THE PARKING GARAGE, WHERE PHOTOVOLTAIC PANELS COULD BE, AND THERE ARE LOTS OF WAYS TO DO IT THAT DON'T IMPACT YOUR (APPLICANT'S) FINANCING. FOR INSTANCE, SAN DIEGO GAS & ELECTRIC HAS A SUSTAINABLE COMMUNITIES PROGRAM WHERE THEY INSTALL IT AND THEY PAY YOU RENT FOR YOUR ROOF. I DON'T KNOW WHY THAT DOESN'T WORK. I THINK THAT'S A PERFECTLY REASONABLE STRATEGY FOR GETTING PHOTOVOLTAICS ON THE BUILDINGS AND GENERATE ELECTRICITY ONSITE WITHOUT IMPACTING YOUR (APPLICANT'S) FINANCING. SO THOSE KINDS OF THINGS WILL NEED TO BE SERIOUSLY EXPLORED, AND I WOULD ENCOURAGE THE CITY COUNCIL TO ALSO CONSIDER ADDING THOSE KINDS OF CONDITIONS."
