### ITEM - 4: **DIRECTOR'S REPORT:**

Bill Anderson congratulated Commissioner Ontai on his being appointed to State Redistricting Commission and wished him well.

They presented the first 180 day extension of the height ordinance for the Uptown Community Plan as part of the Community Plan Update process we presented at the LU&H and it is going to City Council in January. The interim height ordinance was designed to have two extension periods. This is the first extension for 180 days, and then there would be a second extension during the summer (that would take it to January of 2012).

The LU&H Committee recommended to the full council to approve the extension. They added a clause that if budgeting is removed the plan update the interim height ordinance be permanent until the plan is completed. We will see what the full council does when it gets to Council in January...We are going to be discussing conservation areas with the Community Planning Committee in January and we are going to have to make some decisions in the next few months on the role of the Community Plan for conservation areas. Should the Community Plan just propose potential conservation areas and have a separate process for forming them outside of the Community Plan or does the Community Plan actually adopt conservation areas as part of its adoption.

Commissioner Ontai spoke about his appointment to the California Redistricting Commission.
