- Evaluate the project's ability to reduce vehicle miles traveled and contribute to reductions in greenhouse gas emissions consistent with Senate Bill No. 743, which seeks new methodologies for evaluating transportation impacts that are better able to promote the state's goals of reducing greenhouse gas emissions

- and traffic-related air pollution, promoting the development of a multimodal transportation system, and providing clean, efficient access to destinations.
- Evaluate the ability for the project to synchronize traffic signals along primary arterials and major street segments in the Central Subarea of the University Community Plan in an effort to improve street operations and mitigate any traffic impacts created by the project.
- A retail market study to be submitted by the applicant which analyzes the demand for additional neighborhood and community serving commercial uses in the area around the project site.
- A market study to be submitted by the applicant which analyzes the demand for hotel
 use in the area around the project site and the University Community.
 Commissioner Peerson seconded the motion. The motion passed by a vote of 41-2 with Commissioners Haase, Peerson, Wagner and Whalen voting yea and
 with Commissioner Quiroz voting nay and with Commissioners Golba and
 Austin absent.
