### **COMMISSION ACTION:**

COMMISSIONER WAGNER MADE THE MOTION TO CERTIFY ENVIRONMENTAL IMPACT REPORT NO. 182513, AND ADOPT THE MITIGATION, MONITORING, AND REPORTING PROGRAM; AND APPROVE COSTAL DEVELOPMENT PERMIT NO. 662551, SITE DEVELOPMENT PERMIT NO. 662678, AND TENTATVE MAP WAIVER NO. 683254 WITH THE FOLLOWING ADDITIONAL PERMIT CONDITIONS BY THE COMMISSIONERS: 1) THE APPLICANT SHALL INCORPORATE PHOTOVOLTAIC SYSTEMS (SOLAR PANELS) FOR THE PROJECT CONSISTENT WITH CITY'S GUIDELINES FOR THE AFFORDABLE/IN-FILL HOUSING AND SUSTAINABLE BUILDINGS EXPEDITE PROGRAM AND THE ROOF-MOUNTED PHOTOVOLTAIC SYSTEM SHALL NOT EXCEED THE DEVELOPMENT'S 30 FEET COASTAL HEIGHT LIMIT; 2) THE APPLICANT SHALL MAINTAIN ALL ESPALIER/VINE PLANTINGS AS SHOWN ON THE LANDSCAPE DEVELOPMENT PLAN, IN PERPETUITY FOR THE LIFE OF THE DEVELOPMENT; 3) THE APPLICANT SHALL DESIGN AND INCORPORATE AN ADDITIONAL FIVE-FOOT SETBACK, NORTH OF THE ELEVATOR STRUCTURE, ALONG THE THIRD FLOOR LEVEL AREA OF AT LEAST FIFTEEN FEET IN LENGTH ALONG THE EAST BUILDING ELEVATION WALL; AND 4) THE APPLICANT SHALL SUBMIT DESIGN PLANS FOR APPROVAL AND CONSTRUCT A TRAFFIC CALMING MEASURE. SUCH AS ENHANCED PAVEMENT AT THE CROSSWALK ON CALLE CLARA, AT THE INTERSECTION OF EL PASEO GRANDE AND CALLE CLARA, SATISFACTORY TO THE CITY ENGINEER. Commissioner Peerson seconded the motion. The motion passed by a vote 5-1-1 of with Commissioners Golba, Haase, Austin, Peerson and Wagner voting yea and with Commissioner Quiroz voting nay and with Commissioner Whalen absent.
