#### ITEM – 6: **COMMISSION COMMENT:**

Commissioner Quiroz requested Mr. Westlake to provide an updated list of number of condo conversion approved from January 1<sup>st</sup> through December 31<sup>st</sup> of 2015 and she wants to make sure that we don't pass the annual maximum allowed in the Municipal Code. She also mentioned that her neighborhood has been going through water pipe replacement for about a year now and was concerned about the amount of water being wasted for the past months and to make sure that there is no contaminated water running into the storm drains. Commissioner Quiroz requested that the City staff provide her a written

explanation of why this huge waste of water and contamination of our waterways is permitted; and why the city follows different rules than it requires of private developers; and why the city have not change their contracts by companies hired by the city to do the city's work.

Commissioner Haase commented on the mobility issues in our community, the updates from the City Engineer regarding the Street Design Manual and the Senate Bill 743. He stated that the mayor's Vision Zero plan aims to reduce traffic-related fatalities in our community to zero and that cyclists' death and injury on city streets is unacceptable. He asked the Planning Commission to support his request to schedule a Mobility Workshop hopefully sometime in August and it will include City staff, Planning Committee representatives, Members of the Business Improvement Districts, Traffic Analysis Experts and Public Health. Commissioner Haase believes that this will provide some valuable input to the City to achieve the goals listed in the memo from our City Engineer regarding the Street Design Manual and provide communities the opportunity to comment on significance thresholds developed to implement SB 743.
