PRIOR TO THE RECORDATION OF THE FINAL MAP, THE SUBDIVIDER SHALL COMPLY WITH THE AFFORDABLE HOUSING REQUIREMENTS OF THE CITY'S INCLUSIONARY HOUSING ORDINANCE (CHAPTER 14, ARTICLE 2, DIVISION 13 OF THE LAND DEVELOPMENT CODE). PRIOR TO THE RECORDATION OF THE FINAL MAP, THE SUBDIVIDER SHALL EITHER PAY AN INCLUSIONARY AFFORDABLE HOUSING IN-LIEU FEE OF \$200\\$19 OR ENTER INTO AN AGREEMENT WITH THE SAN DIEGO HOUSING COMMISSION TO ASSURE PAYMENT OF THE FEE. IN ADDITION, THE SUBDIVIDER HAS AGREED TO SELL SIX (6) ONE-BEDROOM UNITS AND FOUR (4) TWO-BEDROOM UNITS TO, AND AT PRICES AFFORDABLE TO, HOUSEHOLDS EARNING NO MORE THAN 100 PERCENT OF AMI. PRIOR TO THE RECORDATION OF THE FINAL MAP, THE SUBDIVIDER MUST ENTER INTO AN AGREEMENT WITH THE SAN DIEGO HOUSING COMMISSION TO ASSURE THAT THE TEN (10) UNITS ARE SOLD TO ELIGIBLE HOUSEHOLDS AT RESTRICTED PRICES.
