She also noted that there will be a community clean up scheduled in coordination with the recreation center for sometime in July and that the pot holes near the intersection of Poway Road and Sabre

Springs Parkway have been fixed. Finally it was noted that a ribbon cutting ceremony for the tot lot had been scheduled for June 2<sup>nd</sup>.

#### ***A. Scripps Ranch Community Service Center***

Clay Bingham from the City reported that the Scripps Ranch Service Center is one of fifteen service centers that opened in September. Through the service centers, the City is trying to bring City government services to local communities. The center in Scripps Ranch serves the communities of Scripps Ranch, Peñasquitos, Mira Mesa, and Sabre Springs. Citizens can take care of a number of City related business matters at the service centers rather than having to drive downtown. Services provided at these centers include, but are not limited to, bill payments, parking citation payments and appeals, minor permit application assistance, etc. Public documents are also available for review at these centers.
